RECOGNITION OF VISITORS & GUESTS

IFT Rep Lynnette Scalucca: Just to clarify: This is a union meeting. This is non-work time.

She is here to discuss politics. Most folks understand that governor's race is different than partisan politics. On opening day, she made a request to participate in walks. She shared the video, "Warning: A Message from Wisconsin AFSCME members to Illinois." He states he is ready to take on unions and strip away bargaining rights. AFSCME embers discuss loss of bargaining rights and cuts to salaries. Rauner has stated that Scott Walker is his role model. We need to focus on Get Out the Vote (GOTV). Voter Drop-Off is an extreme challenge for us to overcome. In non-major election years, voting numbers are down, or they "drop-off." Over 40% of local members did not vote in 2010. If that happens, we lose. Turnout is key. We need to get our voters out. We can call our own members. Consider fun activities and raffles for folks who vote early or people who vote early morning on Election Tuesday. Raffles? What can we do to encourage folks to vote? This election is challenging with Drop-Off as Quinn is not a strong candidate and folks are inclined to sit out. Concerns with Rauner include eliminating payroll deduction of dues and subsequent loss of bargaining rights. She is delivering the message and encouraging participation. She is going to be at the Elgin Labor Temple organizing the walks on Saturday. Our average has been 1-2 people from IFT every week. She is providing information on how to register to vote, vote by mail. Woodstock group is doing a social event to mail friends & family letters (template on IFT website). The Board of Trustees approved a contract for custodian consultants at a cost of more than \$87,000 based solely on the recommendation of the President. Luis is still waiting to meet with the President; he will request a meeting.

Jessica was absent. Aspire event looking for 1st generation faculty to participate in an event. Safety Updates deferred to next meeting. Excess Load- discussion amongst the executive committee regarding possibility of midterm negotiations regarding UA1 load assignment. There was no additional information shared.

COMMITTEE REPORTS -

Negotiations- (Howard Russo)

We have a tentative agreement for Wellness Professionals. There was a period of ignoring. They contend that Wellness doesn't teach; they don't want lane or step. There has not been any movement over an extended period of time. So, the administration sold the positions. They removed Wellness Professionals from the bargaining unit. A one-time non-precedent setting offer, professional expense includes and additional \$325 FT and UA and additional \$100, totaling an amount up to \$100,000 for one year. It will not roll over and it will be tapped first so other monies will roll over. Our concern is that we need wellness professionals and this is continuing to drag out. Offers were made to individuals resulting in decrease in pay for increase in work duties. We do not believe this is the ideal outcome. The offer is a benefit for the overall membership, although it is not a great deal. This was presented to our team last Thursday. They feel that this is the best deal we could make. How will this be communicated to the membership? It will be approved at BOT in November and then it will be

announced. Elizabeth Becker moved to approve and second was made by Pat O'Brien to approve the tentative agreement. Howard commented that this was very unique as they bought this from us. The motion passed. Dawn Munson abstained.
