RECOGNITION OF VISITORS & GUESTS

3:45 PM Dean Libby Roeger, Rose DiGerlando, Sharon Colby, Julie Schaid- Dual Credit (see IFT Resolution # 7 addendum)

Libby provided a comparison of Dual Credit in High School versus Dual Credit at College, highlighted ICCB Rules relevant to dual credit, HLC guidelines, and NACEP. Julie reviewed current ECC dual credit offerings. CTE credits offered at high schools are offered proficiency credit option at ECC. Evidence suggests dual credit supports matriculation. Comparing ECC dual credit enrollment to sister colleges, ECC appears to be low. U 46, District 300, 301 and 303 have requested more information about dual credit as public awareness increases. District 300 and an unnamed district are interested in more offerings physically at ECC. District 300 is interested in offerings at the high school location and new hiring credentials have elevated in preparation. St. Charles NORTH has dual credit option with University of Illinois; ECC is not the only option for school districts pursuing dual credit. Our numbers are lower than what Perkins expects and we are not meeting their thresholds with regard to dual credit. There is no current ECC plan in place. Questions & Discussion: Do courses offered at High School have to be high school employees? Do ECC faculty need to have HS credentials? ECC is interested in pursuing dual credit. Many topics were discussed including credentials, evaluation, college experience, limits to the number of credits students can earn via dual credit course taught at the high school, exploring transportation models, pathway offerings, course ownership, potential contractual issues, focus on senior year students, and incremental progress. Rose DiGerlando stressed that they share our concerns and request faculty involvement in any advancement. Faculty will be involved with developing a plan for ECC and representation on a work group has been requested.

New Faculty Orientation Committee- Heidi Eaton, Roda Ryan, Maria Bagshaw (written report distributed to senators)

In the past, this orientation was faculty led and offered by ECCFA leadership. ECCFA historically invited administrators and key support staff to participate and demonstrated collaboration between ECCFA and Administration. This year, the process was very different and attributed to a variety of reasons. Heidi Eaton was approved to facilitate a New Faculty Orientation Committee based on her sabbatical work. She previously shared the new model with the ECCFA and following approval, a committee was formed to further develop and implement. A series of orientation meetings addressing a variety of topics has been developed. D2L modules support ongoing orientation and serve as a resource; face-to-face meetings are included in the model. Roda

Ryan encouraged ECCFA to consider developing a module for the D2L platform. The orientation is a CETL offering and new faculty members earn lane movement credit. This committee was approved by the ECCFA and originally funded by SSI; the team has applied for funding to continue the work. The New Faculty TENURE & EVALUATION Orientation module will be a part of the New Faculty Orientation Committee. Next steps for the committee include developing a program for adjunct faculty.

SSI NEW Initiative:

Members of MAGIC have a long history of advocating for cultural competence and diversity on search committees. Following a national conference, faculty members of MAGIC sought to invite Cris Cullinan, Ph.D. to ECC to present a workshop to anyone involved in hiring processes at ECC. MAGIC collaborated with CETL, SSI Work Group, and HR/Professional Development, and submitted a proposal to SSI. Collectively, we worked with Cris Cullinan, Ph.D. to develop a full-day workshop specifically designed to meet ECC's perceived needs. The workshop was piloted last spring. Faculty were invited to attend. Participants were very supportive of inviting Cris Cullinan back to campus to facilitate a revised, half-day workshop on the integration of seeking cultural competence in the search process. This is not a workshop to promote general cultural competence, but rather is specifically focused on tools and methodologies that will help you craft thoughtful questions and identify culturally competent applicants.

MAGIC would like to point out that this workshop is in alignment with recommendations set forth by the American Federation of Teachers' (AFT) 2010 publication, "Promoting Racial and Ethnic Diversity in the Faculty: What Higher Education Unions Can Do."
