RECOGNITION OF VISITORS & GUESTS

3:50 p.m.- Dr. Sam will address the senate and speak about the budget and the state of Illinois. He states his comments are speculative in nature and shared by others. The budget impasse is ongoing with no predictable end. The Governor wants to change Illinois; anti-union goals. Perkins money goes through the state, and although it is not state money, it is not being disbursed due to the budget impasse. Adult Basic Education (ABE) money is federal and state; those funds are not being disbursed. Letters are being written to highlight the impact on ABE.

ECC anticipated that community colleges will be impacted by budget impasse. The state will run out of funds in the spring. ECC is waiting for payment from past fiscal year, estimated one million dollars. ECC receives 8% of funds from the state; grants are vulnerable. The college is requesting Perkins money as it is federal money. Thus far, that is addressing operations.

Pensions, no matter the solution, they anticipate cost shifting. The state is responsible for 12% and are not meeting their obligations. Past efforts to negotiate this with the state have failed.

ECC's pension liability is \$256 (old liability) or \$19 (current liability) million dollars? The liabilities of the state's community colleges are similar. We are not aware of He states that much of college's funds are restricted.

Retiree Health Insurance shared costs by the college and the state.

Free Community College is questionable.

ECC is not pursuing offering 4 year degrees as it is not related to mission nor is it affordable.

Monetary Assistance Program (MAP) is interrupted.

We are not expecting back payments from the state.

This is simply to inform the faculty of challenges being faced by the state.

Good news- ECC is fiscally sound and does not anticipate interruptions, however, impact of external services on our students and their families is significant.
