Dr. Sam welcomed the faculty back to campus and gave kudos to the faculty for contributions to successful HLC Accreditation. He encouraged continued creativity and innovation despite the state of Illinois budget crisis.

Membership Address: Tony Schuls & Marilyn Westerhoff, ECCP3

ECCP3 is the statewide group, part of SUAA, acting as a watchdog group charged with protecting pensions. The state pension problem is a revenue problem. Tony Schuls explained the impact of pension reform on spouses and provided rationale to encourage spouse/partner membership. Member's spouses/partners will receive 50% of your pension. Current membership is 450 members. ECCP3 membership forms were shared with the faculty and requested to send to M. Westerhoff via interoffice mail.

Financial challenges in the state are a concern, however, there is a national level threat that may impact the effectiveness of unions. The Frederich's case before the SCOTUS, threatens "Fair Share." Currently, members of bargaining units who are not members of the union pay fair share dues, and the union is required to represent those non-members. She referred to the Abood case from 1977, which ensured fair share dues. Because of Abood, the lower courts have ruled against Frederich's and it is

now before the SCOTUS. The remedy or antidote for unions is to organize. She acknowledged the efforts the ECCFA has been taking regarding its membership and signature cards.
