Secretary's Report: Kimberly Tarver

Approval of April 19, 2017 Minutes.

Received note of appreciation from Elgin Township Democrats.

Move to approve by Howard Russo and Jessica Carpenter. Motion passed with 3 abstentions.

Howard Russo and Jessica Carpenter move to accept new senators. Motion passed.

Election of Officers: Vice-Presidents, Secretary, Treasurer and Parliamentarian

1st Vice President- Kimberly Tarver & Kris Campbell nominated Patrick Gordon; he accepted the nomination. The motion to elect Patrick passed.

2nd Vice President- Mary Elfring & Woody nominated and seconded Diane Flahaven; she accepted.

3rd Vice President- Mary Elfring & Ellie Swanson nominated and seconded Adam Burgess; he accepted. The motion passed.

Secretary- Mary Elfring & Woody nominated Kimberly Tarver; she accepted. The motion passed.

Treasurer- Kris Campbell & Tammy Ray nominated Woody; he accepted. The motion passed.

Parliamentarian- Kris Campbell & Mary Elfring nominated Ellie Swanson; she accepted. The motion passed.

Tim Malone, Communications- he shared a proposed action plan emphasizing internal and external communications; member outreach including regular communication; bulletin board updates; outreach to students, social media, possible partner with internal and external unions. Consider hiring student worker or retired faculty member. Is ECC able to access student workers? A scholarship? Note, many of the suggestions relate to membership and would be directed by membership or communications. Recommend consulting Lynnette Sculucca to explore IFT options. Should we pursue newsletters? Paper and/or electronic. Coordinate with other unions and IFT to add information.

Treasurer's Report: Steven "Woody" Wood

A major fraud was avoided after Luis' email was hacked. Law enforcement is involved.

Question & Discussion: What steps are in place or should be in place to avoid future incidents? There is a form and processes may be updated to require signatures. Propose bylaws change and/or procedures. Financial procedures statement reference in bylaws. Ellie read the current language. Financial procedures may be drafted and submitted to the next meeting. Les recommended linking financial procedures, approved by finance committee or senate, to the bylaws.

Danielle Straub moved and Pat Brutchin seconded a motion to draft language to modify financial procedures to minimize risk.

Luis Martinez and Woody agreed work together and submit a proposal to the senate to clarify financial procedures and include a proposed bylaws change. And explore including specific guidelines for a set threshold.

Danielle Straub rescinded the motion.

President's Report: Luis Martinez

Dr. Enyard is gone.

Press conference was held with ECC police officers alleging harassment.

Les McTighe moved to call for acclimation by the senate to request an investigation into the matters raised by the police officers. Seconded by Mary Elfring.

Kimberly amended and Les seconded the amendment to insert "independent" before investigation.

The amended motion reads as, "By acclimation, the ECCFA Senate requests an independent investigation into the matters raised by the police officers.

The motion passed.

New BOT members were seated at meeting last night. Luis welcomed them and expressed desire to work with them; he expressed gratitude to retiring trustees. He extended support for Sharon Konny in her new role overseeing HR.

Discussion moved to closed session.

Search for new chief of police will include vetting by external organization.

- **ELECTIONS** (Tim Anderson) Elections were held on 4/24 and 4/25, and the committee met to count results on 4/26. As of today, 5/2 the results are still being kept confidential while we wait to hear back from write-in candidates that either won a seat outright or tied for an open seat to confirm their willingness to serve. An initial email burst was sent to all impacted on 4/26, and a follow up was sent on 5/1 to those that had not replied. Members of the committee feel that a discussion of electronic voting methods should be considered for future elections.
