During August of 2012, the first wave of E.C.C. faculty "invaded" Cuba. Joyce Fountain, Clark Hallpike, Bill Pelz and I took advantage of the changes in travel restrictions to visit the island. Collectively, the goal was to further our

cultural knowledge base, while also observing a nation in transition. As the economic and political changes continue to evolve, we felt compelled to witness this metamorphosis!

#### ECCFA PARTICIPATES IN ANNUAL FOOD DRIVE

For the fifth year, the ECCFA is taking donations for its annual food drive to help the Northern Illinois Food Bank. The food drive started on December 3 and will run through December 14.

"We all know hunger in our area, and all over, is on the rise. People who used to donate are now needing assistance themselves," said Rick Bonnom, ECC faculty association volunteer coordinator.

A new aspect to the food drive this year is the virtual food drive. This allows donators to go online to purchase items for donation. Collection sites are also set up around campus, and monetary donations are accepted.

Bonnom said donations and the virtual food bank options have extra benefits.

"They [the food bank] can buy in bulk and get discounts, so it is much cheaper than donating actual food. The donations can be stretched even further than taking in food," he said.

Donating \$1 is equal to 6 meals; \$5 is equal to 30 meals; \$10 is equal to 60 meals, and \$20 is equal to 120 meals.

The ECCFA has been participating in the food drive to support Northern Illinois Food Bank since 2008. Last year, the drive collected 844 pounds of food and \$1565 was. In total, 3518 pounds of food and \$4776 have been collected.

After our delicious lunch, most of the 17 of us MAGIC members and guests strolled the short

mile to the *Symphony Center* to listen to what we had been told was going to be a musical experience extraordinaire. We were joined there by others from ECC.

Our own Luis Martinez has a copy of a documentary about the *Venezuelan Youth Orchestra*, which he presented and then discussed at a MAGIC meeting before we went to listen to the orchestra ourselves. As most of you probably already know, Luis is a native of Venezuela. If you get the chance to watch the film, you will certainly appreciate what magic that music has played in Venezuela and subsequently around the world.

The U.S. has also benefited greatly, not just from the orchestras touring around our country, but the musical director of the Los Angeles Philharmonic, Conductor Gustavo Dudamel, is a product of the Venezuelan Youth Orchestra. And fortunately for us in the Chicago audience, this international superstar, as he is referred to by many, was the conductor at our performance! And he was amazing. He didn't use any sheet music during the entire program, and the tone (musical) poem by Strauss that the orchestra played after the intermission was almost one hour long! You could visualize the love of the music as you observed each member of the orchestra on stage.

One of my favorite moments came after the concert ended. I snapped a picture with my cell phone of the longest encore request that many of us have ever heard. People were standing, clapping, and shouting out in Spanish for the conductor and his orchestra to play another song. After that one piece, the standing ovation

and uproar began again. We ended up listening to two more pieces. One was a patriotic Venezuelan song that had many in the audience waving their Venezuelan flags. The conductor and the orchestra members started to sing and asked those in the audience to join them. The pride in the voices and on the faces of those around us and on the stage was an emotionally moving time.

As we were exiting, Clark Hallpike was fortunate to get his picture taken with José Abreu, who formed the *Simon Bolivar Youth Orchestra* in 1975 (see photo to left).

After the concert, the ECC group all met at the *Starbucks* next door to share our impressions of the experience. Everyone truly enjoyed the *magic* of the adventure. Arturo Vazquez, a musician himself, and his guests certainly appreciated the dedication that these young musicians have for their music. One marketing student and her

husband joined us as well; Kathleen was thrilled with the cultural experience and the opportunity to interact with faculty outside the classroom. Kim Tarver found the music to be relaxing and invigorating. She compared the entire day's events to a massage of the mind, the heart, and the soul. # **Important Changes in Meal Allowances**

Regarding: Administrative Procedure 2.601 Travel and Business-Related Expenses: Section XIX Meal Allowance Rates (effective July 17, 2012).

As of July of this year, Administrative Policy 2.601 changed dramatically when it comes to meals and reimbursement. No longer do faculty have to submit every single receipt for meal allowance as there is now a set daily allowance that faculty can claim. **However**, it is important to understand exactly how much those rates are. The meal allowances depend on the following factors:

- 1) Whether the travel is to a major or non-major city (listed in the procedure on pp.9-10),
- 2) Whether the travel day is the first/last day of travel or not
- 3) Whether there are meals provided at the activity.

Let's first look at items 1 and 2. If the activity is in a major city, the allowance is \$45 per day for the first and last day of travel and \$60 for any days in between, regardless of departure or arrival times. The first/last day can start at 8 a.m. or 8 p.m., the allowance is the same. If the activity is in a non-major city, the allowance is \$30 for the first and last day of travel and \$40 for any days in between. So what does this mean? Let's look at the following example:

You go to a 4-day conference but arrive the night before the conference starts because the conference has an 8 a.m. start time. Your meal allowance would be figured as follows:

Major city		Non-major city	
2 days * \$45 =	\$90 (first/last day)	2 days * 30 = \$60 (first/last day)	
3 days * \$60 =	\$180	3 days * \$40 = \$120	
Allowance total = \$270		Allowance total = \$180	

Now let's look at item 3. If there are any meals served at the activity, you must deduct these from the daily allowance regardless of whether you eat them or not. You cannot opt out on a "free" lunch and then ask the college to pay for your lunch at another establishment. The amount that you must deduct from the allowance again depends on whether it is a major/ non-major city and whether it is the first/last day or not. The amounts to be deducted are on the following table.

	1st day/last day			Other days	
	Major City	Non-major city		Major city	Non-major city
Breakfast	\$7.50	\$6	Breakfast	\$10	\$8
Lunch	\$15	\$9	Lunch	\$20	\$12
Dinner	\$22.50	\$15	Dinner	\$30	\$20

So let's go back to the example and say that the conference provides lunch for the 4 days. You would then have to adjust your daily allowances for the activity as follows:

Major city	Non-major city
2 days * \$45 = \$90 (first/last day)	2 days * 30 = \$60 (first/last day)
- 1 day lunch - \$15	- 1 day lunch -\$9
= \$75	= \$51
3 days * \$60 = \$180	3 days * \$40 = \$120
- 3 days lunch - \$60	3 days lunch -36
= \$120	= \$84
Allowance total : \$75 + \$120 = \$195	Allowance total : \$51 + \$84 = \$135

(\*notice that you don't subtract lunch for the first day because it wasn't provided)

The Faculty Development Committee is in the process of revising its forms to reflect these changes, but it will take some time since they have to go through a formal approval process. **However, this policy has already taken effect**, so be sure to follow it when submitting for meal reimbursement. The Faculty Development Committee will adjust your request if the amount exceeds these allowances; however, it is not the Faculty Development Committee's responsibility to adjust requests if there is an under-request for meals. Be aware – receipts are not required at present, but meal allowances will be closely monitored by the Business Office.
