# **Interesting Loop Hole in the Withdrawal Policy**By Cindy Hutman

I had a student this semester who came to every class and took the in-class multiple choice portion of the exams but never turned in essays or assignments, never posted to the discussion or did homework. Eventually I confronted her about this. She shrugged her shoulders and said she "wasn't good at writing." I asked if she understood there was no way to pass the course without doing that writing. She said she did understand. I remind all students of the 10<sup>th</sup> week withdrawal deadline. She remained in the course.

A week after the 10<sup>th</sup> week withdrawal deadline, I get a notice that this student has been withdrawn from the course for "non-payment." I have never had a student withdrawn this late in the semester for non-payment and questioned the accuracy of this. I was surprised to learn that this student had defaulted on her last tuition payment and therefore she had been withdrawn from her courses. Not withdrawn as in "W" or "AW" but her transcript had been wiped completely clean. So, although this had been a financially damaging 11 weeks, her academic record is completely clean!! This is an interesting way to get around the college's ACADEMIC withdrawal policy. Set up a payment plan for tuition. Try out a class. If it looks like it is going to be too much work, stop paying and everything disappears.

# **ERIN'S LAW**

This past April was designated as "sexual assault awareness" month on the campus of E.C.C. As such, there were a number of informative presentations given by the staff of the Community Crisis Center. April 25<sup>th</sup> was the date of the final event of the series which concluded with a "Take Back the Night" rally and march throughout the campus.

One of the speakers for the 4/25 event was Erin Merryn who is the driving force behind what has come to be known as "Erin's Law". Erin discussed her history of childhood sexual abuse, which began at age six, at the hands of two different assailants. As part of her discussion she noted that she did "not tell" anyone of the abuse because she did not have the words to describe what was happening to her. She expanded on her experience adding that educators prepare children for tornados, "Stranger Danger", how to say NO to drugs, etc., BUT neglect to provide children with any sort of vocabulary or context to deal with sexual overtures at the hands of predators (often very "trusted" people) in their worlds. The possibility of sexual abuse intruding into the lives of children is far more likely than we would like to acknowledge!!! The data suggest the following:

- Every 6 minutes a child is sexually abused in the United States
- I in 4 females and I in 6 males will be sexually assaulted before reaching the age of 18
- Only I in 10 children who are sexually assaulted with tell someone.

"Erin's Law" is an attempt at providing proactive remedies.

According to her web site (<a href="http://www.erinslaw.org">http://www.erinslaw.org</a>)\*, "Erin's Law" requires:

- All public schools implement a prevention oriented child sexual abuse program that teaches:
  - Students preK-5<sup>th</sup> grade, age appropriate techniques to recognize child sexual abuse and tell a trusted adult
  - School personnel about child sexual abuse
  - Parents and guardians the warning signs of child sexual abuse, plus needed assistance, referral or resource information to support sexually abused children and their families.

This law was extended in the state of Illinois on January 24<sup>th</sup>, 2013. The implementation should take place by January 2014. Other states in which "Erin's Law" has passed include Indiana, Maine, Missouri, and Michigan. It is pending in Georgia, Minnesota, Mississippi, Nevada, New Mexico, New York, and Pennsylvania. Ms. Merryn has made the goal of passing this legislation in all 50 states her life's work. I would encourage you to visit Ms. Merryn's website\* for additional information on this topic.

# ...Loophole Continued

Let me turn this around. A fiscally responsible student signs up for a course, pays all his tuition immediately. He realizes before the 10<sup>th</sup> week withdrawal date that the course is going to be too much right now and has to withdraw. A "W" will appear on his transcript. Not as bad as an "F" but not as good as having your transcript cleared as happened for the fiscally irresponsible student. Or, far worse, the fiscally responsible student who realizes after the 10<sup>th</sup> week that he is not going to be able to successfully complete a course that is completely paid for. He can't withdraw, he receives an "F" on his transcript. While I have no problem with this result given the college policies, I do have a problem with this student suffering an "F" because he paid the college on time while the student who didn't pay on time suffers no penalty on her transcript.
